I would like to extend my sincere thanks to each of you for the support you provided to the Israeli International Law Program. I was a late applicant to this year's program, which meant the flights were more expensive than usual. As a result, the trip would not have been feasible, absent your support. I learned a lot while on the trip - about the country, and the students I attended it with, especially, so it was invaluable.

Israel is a beautiful country, and it was an absolute privilege to visit. Being there radically changed my thinking about it too - on the first day, the school impressed upon me that venturing outside of Tel Aviv or West Jerusalem was risky for a gay student (particularly as one who does not pass as straight). This was largely borne out in the following weeks, and the lesson - that I'm safe in Israel, and not so much elsewhere - was not lost on me. It is easy to be sympathetic to people who are willing to protect you. I would go as far to say that Israelis are more comfortable with gay people than Canadians are, which was a shock, since it means we have a long way to go still.

While there are many things to admire about Israel, the people certainly were the most remarkable part of it, for me. Israelis are hearteningly different from Canadians - they're direct, warm and seem happy, in a way that I rarely see in Winnipeg. The contrast was enlightening, and I hope I'll be able to put that to use here. It would be nice if people here were a little happier, I think.



I would like to express my deep gratitude for your generous contribution to the *Mishpatim* program at the Rothberg International School in the Hebrew University of Jerusalem. The opportunity to travel to Israel for a month was an unforgettable experience - and it was all thanks to your help and support! I was able to make new friends (and future colleagues in the legal profession) and travel throughout Israel and learn more about its culture, history, and people. It was a privilege to have a unique experiential learning opportunity in the *Introduction to Israeli Law and Society: Ancient Peoples and Newcomers in the Start-up Nation* course.

The course was an excellent opportunity for students from different Canadian law schools to meet and study together. In our seminar, we studied different legal issues and topics, such as difference sources of Israeli Law; judicial review and jurisprudence; Israel as a Jewish and Democratic state; language, identity, and electoral politics; and the Israeli Knowledge Economy, among others. We were lucky to have Professor Daniel Ohana teach the course along with Professor Byan Schwartz and several distinguished guest speakers. We were also very fortunate enough to be in different classrooms at the Faculty of Law and the Rothberg International School to experience the beautiful campus overlooking the Old City. In addition to our coursework, we were also able to participate in excursions around Israel as part of our learning experience. We visited places such as the Yad Vashem Holocaust

Museum.
